Gathered Mr. Valeriy Akhumyan, President of the European Union of Futsal (UEFS onwards) and Mr. Jordi Eduardo Aubeso, President of the Catalan Futsal Federation (onwards FCFS), on behalf of the UEFS and FCFS respectively, mutually recognizing the representation they hold.

Agree to transfer the Permanent Headquarters of the General Secretariat of the UEFS to Catalonia, for what will be supported and FCFS collaboration, which will facilitate the location of the headquarters of both logistical and economic issues. For what it sets out the following agreements or covenants:

1-Mr. Valeriy Akhumyan as UEFS president is committed to upholding the UEFS congress to be held in Barcelona on 28 of these, so it is the Congress who approved the relocation of Headquarters General Secretary at the site now occupied by the delegation UEFS in Catalonia purpose and negotiate with the countries present at the Congress in order to carry out that goal as of March 1, 2010.

2-Mr. Valeriy Akhumiyan also agrees that during the course of Congress and on the basis of the attributes that give the Article 34 of the Statutes of the UEFS appointed as General Secretary of the UEFS a person of nationality Catalan, who will head the General Secretariat and should structure a new department whose organization must approve the Executive Committee to be held in the city of Kaliningrad during the course Eurofutsal of 2010 to be held from 2 to May 9, and to be proposed by the designated person.

3-Mr. Valeriy Akhumiyan during the congress informed of the decision to appoint José María Zamora Monje as the new General Secretary of the UEFS with effect from March 1, 2010.

4-The FCFS with the collaboration of the Department of International Relations of the Generalitat de Catalonia assume those costs arising from the location of the headquarters of the General Secretary of the UEFS in Catalonia, including the costs to be borne addition to the structural, currently already being assumed by the location of the Delegation of the UEFS since January 2008 (See, services, computer equipment, office equipment, communications) to provide an amount for UEFS proper functioning of the General Secretariat of where you have to leave the salary of the General Secretary, in accordance with the budget on which this agreement has been discussed is for a total of 21,000 € net per year to be received by 14 monthly payments, as governed by the laws in Spain and Catalonia (reviewed annually by the IPC in Catalonia) and travel expenses to properly develop the performance of the duties of General Secretary. In any case, the maximum amount the FCFS will provide a total of 28,000 € per year. in subsequent document will set out the details and details of this contribution.

5-Mr. Jordi Eduardo as president of the FCFS with effect from March 1, 2010, established what is necessary for the proper operation of the Headquarters of the General Secretary, Physical location of office, provision of telephone, fax, Internet DSL, and computer and office equipment necessary for the normal functioning of the Secretariat.

6-Mr. Valeriy Akhumiyan and Mr. Jordi Eduardo Aubeso undertake in advance to study the possibility of moving to Catalonia Official Headquarters UEFS in the near future.

This agreement is a permanent and indefinite, automatically renewable for election periods and to review must be terminated by either party with a minimum of 3 months.

What has been agreed for the purposes of March 1, 2010 in the city of Barcelona to February 26, 2010.
